AB341 is featured in the Republic Services 3rd and 4th quarter 2012 newsletter released to residents and businesses. AB341 is also added as a link in the City of Artesia website. LARA has a link to CalRecycle's information on AB341; Beverly Hills (34,003.01 tons): In 2004, the City of Beverly Hills Commercial pick up was awarded to Crown Disposal Co. Inc. All of the City's material is processed at Community Recycling & Resource Recovery Inc. In July of 2012, the City begin working on expanding its education/outreach to commercial businesses and multifamily properties. Tonnage represents total commercial material recycle; Bradbury (0.94 tons): For AB 341 compliance, the City met with CalRecycle. The LARA website has a portal for AB 341 FAQ'S; Duarte (122.31 tons): With the onset of AB 341, Burrtec Waste, the City's licensed hauler, continues to encourage commercial recycling through the creation of individualized programs for each site. Staff is also exploring acquiring a grant from CalRecycle to further tap into this segment; Hermosa Beach (1,948.53 tons): The City has developed and will adopt a Mandatory Commercial Recycling (MCR) Policy. MCR Plan will submit a list of all commercial and multifamily accounts from the new franchise hauler identifying all accounts subject to MCR compliance and the top 10% of waste generators and all accounts that are not currently recycling. New franchise hauler will begin service July 1, 2013. All MCR educational/ outreach materials will be submitted as received from the new franchise hauler; Hidden Hills: The City of Hidden Hills has no commercial business or multifamily facilities within the City. The only facility that falls under the AB 341 regulation is a school.
