Rancho Palos Verdes: Increased recycling by 71.75 tons via the multifamily Beverage Container Recycling Grant. Automated 3 cart collection began July 2010. 6,167.96 tons diverted in 2011, including multifamily collection.

Redondo Beach: On July 1, 2011, the City of Redondo Beach implemented a new contract with Athens Services to collect trash, recyclables, and compost. The compost collection includes food, food-soiled paper, and yard waste. Additionally, the trash portion is run through a municipal solid waste material recovery facility to capture more tons. The tonnage numbers are lower than in 2010 because of the multifamily portion, the recycling tonnages are now accounted for with the commercial program in Athens' reports.

South Gate: Residential commingled, curbside, and automated recycling continues. The city increased its public education campaign to local residents from a mandatory 1 time per year to a mandatory 4 times per year as part of their work to reach all residents with compelling information about recycling.

Manhattan Beach: Waste Management provides residents with a postage paid mail back pharmaceutical bag upon request. Also, the Waste Management SHARPS by mail program continues with the co-payment eliminated beginning June 1. As of June 1, all City facility hazardous waste is collected by Waste Management's At Your Door Company for proper recycling and disposal.

Palos Verdes Estates: Residents may also drop off dry cell batteries and fluorescent light bulbs at the Lunada Bay Hardware Store.

Rancho Palos Verdes: Approximately 33.25 tons of HHW were collected at the HHW roundup event in May. The City also offered Sharps disposal containers to residents.

South Gate: Waste Management and the City of South Gate launched an at home delivery program for SHARPS containers.
